“New Discoveries from the Past.”

Campers will learn of the dramatic changes to the WCHS's Harmon Museum over the last year, with its many new exhibits and refurbished existing ones. Heading the list is the [1795 Beedle Cabin](#), which is being reconstructed next to the WCHS's Armstrong Conference Center.

The Beedle Cabin was one of the first cabins constructed in Warren County. In the fall of 1795, it was built by New Jersey-born William Beedle, his five adult children and their families when they established Beedle Station, the first permanent pioneer settlement in Warren County. The station was located 4 mile west of Lebanon.

Besides seeing the new exhibits at the Harmon Museum, campers will also enjoy “historic” guest speakers, and be involved in activities that will open their eyes to the vivid history that surrounds us in southwest Ohio.
